The right to vocational training (10)	Provide or promote, as necessary, the technical and vocational training of all persons, including the handicapped, in consultation with employers' and workers' organisations, and grant facilities for access to higher technical and university education, based solely on individual aptitude (10.1) (2016) ^a
The right to vocational training (10)	Provide or promote a system of apprenticeship and other systematic arrangements for training young boys and girls in their various employments (10.2) (2016) ^a

The right of migrant workers and their families to protection and assistance (19)	Permit, within legal limits, the transfer of such parts of the earnings and savings of migrant workers as they may desire (19.9) (2015) ^d
