It is one of eleven Ukrainian Catholic church-sponsored charitable organizations, each of which is co-located in the eleven Eastern-rite Catholic eparchies in Ukraine, and all of which are part of the Vatican's global network of charitable organizations. The eparchy of Sambir-Drohobych includes six administrative districts of the Lviv region with a total population of 568,500, all of which are part of Caritas' charitable ministry.</p> <p>Our organization operates out of a building in the center of Drohobych (population in the city and region: 200,000) which contains office space, a tiny chapel, recreational area for children, and adjacent space for a kitchen and dining facility, classroom, and special needs rehabilitation. Our mission is to solve social problems and to assist the most needy people, regardless of age, gender, religion or place of residence. Our priority has been to work with street children, children from vulnerable or pathological families, migrant children, and children with disabilities. In addition we provide family counseling training, assistance to Internally Displaced People and their children, assistance to victims of human trafficking, working with alcohol and drugs addicts, promotion of voluntarism, and assistance to the elderly and homeless.</p>

In the frame of the Regina Pacis Foundation operates a team of competent specialists, which have the meant to achieve its projects and initiatives with enthusiasm and faith, the qualities that showed also the people who laid the foundation of the present organization.

Today, Regina Pacis Foundation is proud of the results of activities carried out through its structures in the Republic of Moldova, including in the Transnistrian region.

All these generate the new forces, strengthening the faith and the spirit of the persons of Regina Pacis Foundation in their daily work to the benefit of the society.

What could you offer in term of experience, best practices and knowledge to the network of organizations participating in the CEE program?

1. Regina Pacis Foundation has successfully implemented several projects financed from EU funds. Within the project "Never Alone" conducted by the Foundation "Regina Pacis" in the Transnistrian region (2009-2011) funded by the UNDP from the EC funds it has gained an important experience with the partners from the Transnistrian region and from Europe in the field of improving the dialogue between those two sides of the Dniester river (the relations that have suffered from the armed conflict in the early '90).

2. The good practices in the field of emigrants training were accumulated within the project "From Moldova with an address in the Pocket", implemented under the provisions of the bilateral agreement on labor migration signed between the Italy and the Republic of Moldova on July 5th, 2011 in Rome, the Ministry of Labor and Social Policies in Italy, has entrusted (as a result of conducting a tender for selection of projects on the use of the European Fund for integration of third-country nationals 2007-2013), to some Italian institutions the implementing in the Republic of Moldova of some projects of Italian language training, Italian civic education and culture and the classes of security at the work place, directed to the development of the qualification levels of migration flows towards the Italy.

3. The notorious experiences in the field of training the teaching staff of the vocational education were accumulated by the Foundation "Regina Pacis" as the local partner and **CEFAL Bologna**, within the project "Strengthening the migration management capacities in the Republic of Moldova", implemented by the Sweden Employment Public Agency in partnership with the General Directorate for Immigration and Integration Policies of the Ministry of Labor of Italy and the Ministry of Education of the Republic of Moldova, financed

by the European Union.

4. The best practices in the field of implementing the new methodologies in the foods sector have been brought within the project AFORIL Project (CUP n. J25C13000160007) - which was promoted by the **Mediterranean Agronomic Institute of Bari, Italy** in partnership with the **Foundation "Regina Pacis"**. The project was financed by the European Fund for the Integration of Third Country Nationals (EFI) for the period 2007-2013, approved by the Ministry of Interior of Italy (Decree no. 7905 of 27/12/2013) and implemented after the signing the Convention of Financing with the Ministry of Agricultural and Forestry Policies of Italy.

5. Another experience gained is the project "Renovation of the kindergarten **"LACRAMIOARA"** of village Varvareuca, district Floresti, by the contributing to the multilateral development of children from Kindergarten "Lacramioara" of village Varvareuca through the providing the access to the training and quality preschool education. The project was implemented by the Foundation "Regina Pacis" with the financial support from KINDERMISSIONWERK of Germany.

6. Also a beautiful experience was gained within the project **"Our future depends on us!"** that provides the education and vocational training of the juveniles detained in the Penitentiary No. 10 of GOIAN, district Criuleni in the following areas: cook, barber and cobbler. This is an innovative project as the juveniles and young prisoners are motivated in achieving such professions and correspondingly the education and vocational training in detention period will be useful in the future, after the release from detention, in order to find a job. The project is the first time implemented in the Republic of Moldova by the Foundation "Regina Pacis" with the financial support of the Association RENOVABIS of Germany.
