Title: The beginnings of a Territorial Innovation Model in Northern Rural England?

The paper is an early analysis of interviews that were conducted as part of my PhD project. It shall present the main thematic themes that occurred and how these relate to the discovery of a TIM in rural NE England.

Design/methodology/approach (including limitations if applicable)

The methodology was rather simple as it was one component of a larger PhD project. 10 interviews were conducted between Nov 2016 – Feb 2017 with key regional stakeholders in the innovation and enterprise ecosystem.
