Title: Challenges and Barriers to Sustainable Business Model Innovation in Swedish Agri-food Production

Purpose of this paper (please also indicate whether empirical, conceptual or case study etc)

The aim is to explore and illustrate how sustainable business models (SBM) have developed in the Swedish agri-food sector, and to visualise the challenges and barriers to SBM innovation. The aim is also to contribute to research about SBM in the agri-food sector, since this research is limited and there is a need for solving the society challenges related to an increased global food production.

Design/methodology/approach (including limitations if applicable)

Six case studies from Sweden provide the data. Primary data includes in-depth interviews with agricultural entrepreneurs and documents from the companies.

Findings

Similarities and differences regarding, ways of thinking and acting, business model innovation activities, barriers and challenges are identified. The entrepreneurs are aware of necessary changes in mind-set regarding running businesses, understanding the need for change from traditional farming to professional businesses, from having the business as a lifestyle, with the family involved and usually living at the firm - to a professional company, sometimes in larger scale, but most important with good self-leadership. They see greater economic profitability in diversification, and some driving forces for change are dissatisfaction with pressure from big cooperatives, increased competition from imported food and ability to control and influence their future. Some barriers to innovation in form of legislation and the Swedish advisory system are shown, but otherwise the entrepreneurs are solution-oriented and see opportunities in for example cooperation with neighbours and other stakeholders in a way that traditionally have not existed in Swedish agriculture. Ecological sustainability is in focus for the agri-food entrepreneurs who work and live in symbiosis with nature, so this approach is not new. Neither is economic sustainability. However, the social sustainability is increasing in importance and awareness.

Practical implications

The results will increase the understanding of developing SBM. Implications for research and practice are to focus on cognitive barriers and drivers in BMI process.
