### Important Information

#### *Completion of Study Visits*

As we move into follow up, a quick reminder to sites regarding the importance of ensuring **all study visits** are conducted for each participant in line with protocol requirements (and that all data is entered in MACRO In a timely manner) to ensure completeness of data within the study. This is particularly important as it ensures that the data available for analysis at the end of the study is as complete as possible and will help to generate high quality results.

### Data Clarification Requests

Now that all NATTINA participants have had their baseline visit, we will start the process of data cleaning. Please look out for Data Clarification Requests (DCRs) on MACRO (red flags on a CRF/question highlighting that this data should be checked) and action these as soon as possible. Please remember to not only amend data (if necessary), but also to respond to the DCR (by right clicking on the question), so we can clear the request.
